**RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT**

IN CONSIDERATION of being permitted to enter for the purpose of support and/or participation to the event(s) within any restricted area (herein defined as including but not limited to the racing surface, pit areas, infield, grandstand area, and all walkways, concessions and other areas appurtenant to any area where any activity related to the EVENT(S) shall take place, or being permitted to complete, officiate, observe, work for, or for any purpose participate in any way in the EVENT(S), each of the undersigned, for himself/herself, his/her personal representatives, heirs, and next of kin, acknowledges, agrees and represents that he/she has, or will immediately upon entering any of such restricted areas, and will continuously thereafter, inspect such restricted areas and all portions thereof which he/she enters and with which he/she comes in contact, and he/she does further warrant that his/her entry upon such restricted area or areas and his/her participation, if any, in the EVENT(S) constitutes an acknowledgement that he/she has inspected such restricted areas and that he/she finds and accepts the same as being safe and reasonably suited for the purposes of his/her use, and he/she further agrees and warrants that if, at any time, he/she is in or about restricted areas and he/she feels anything but safe, he/she will immediately advise the officials of such and will leave the restricted areas.
