## **Disciplinary Notice**

**Dated:** July 9, 2024  
**Competitor:** Kyle Devendorf and the Devendorf Racing Team  
**Regarding:** July 6 DIRTcar Sportsman Feature at Fulton Speedway

---

**Violation:** Kyle Devendorf and team owners, Tim and Kelly Devendorf, were involved in a series of unsportsmanlike and harassing incidents after the July 6, 2024 DIRTcar Sportsman Feature at Fulton Speedway.

Specifically, Mr. Devendorf and his team committed the following prohibited acts:

1. Kyle Devendorf entered the trailer of another driver without permission and verbally accosted said driver. Additionally, he entered the pit area and verbally accosted another driver without invitation.
2. Separately, car owner Tim Devendorf directed threatening and harassing language at one of the same teams.
3. Car owner Kelly Devendorf physically and verbally accosted the mother of another competitor.

These actions specifically violate Section 7 subsections E and F of the 2024 DIRTcar rulebook that governs competition at Fulton and Brewerton Speedways. These rules read:

*E. Any member and/or participant that goes into another competitor's pit area and/or to another competitor's car and becomes involved in any type of altercation will be subject to penalty and/or disqualification and/or fine and/or suspension and/or legal action and/or any other action deemed appropriate by World Racing Group Supervisory Officials.*

*F. Any member and/or participant involved in an altercation that results in physical contact will be subject to penalty and/or disqualification and/or fine and/or suspension and/or legal action and/or any other action deemed appropriate by World Racing Group Supervisory Officials.*

**Penalty:** As a result of these actions, driver Kyle Devendorf and the Devendorf racing team have been suspended from competition at both Fulton Speedway and Brewerton Speedway for two racing events at each track.

When eligible to return, the driver and team will be on a zero-tolerance probation for the remainder of the 2024 season.

The Devendorf team is reminded that any derogatory or inflammatory response to this penalty on social media or in

person directed at either the tracks or other teams involved will result in further penalty as per Section 7 subsection D:

*D. Unsportsmanlike conduct or participating in any action or activity considered detrimental to DIRTcar racing or a DIRTcar sanctioned track, at any sanctioned event or on social media, by drivers, owners and/or pit crews shall be grounds for disqualification and/or punitive action by DIRTcar Racing*

It is the expectation of Speedway management that drivers and teams display appropriate sportsmanship at all times and harassing, threatening and irrational behavior will not be tolerated.
